John still has not heard anything from the IRS regarding our 501(3)c status. John called the IRS and was able to speak to someone who wrote a report and referred him to a taxpayer advocacy group who asked for 30 days after which, we would be given priority status if the matter has not been resolved.

WEBSITE UPDATE:

Mike Pugh handed out the website statistics pages which showed we had 632 visits to the website in October. Our top pages viewed were our about page, Lifelinks, spiritual adoption, and frozen embryos.

RADIO SPOTS/MAGAZINES/BOOKS:

PLANNED PARENTHOOD PRAYER VIGIL/40 DAYS FOR LIFE:

Maureen and Heather talked about the 40 Days for Life campaign.

Maureen gave a brief report on what the 40 Days for Life was like.

There will be a meeting next week Tuesday at 7pm at her home to discuss with the participants some ideas for the next vigil.

Maureen ordered more literature and brochures for 40 Days for Life as well as the St. Michael's prayer. The total came to \$219.39. A motion was made and seconded to reimburse Maureen the cost of the purchase.
