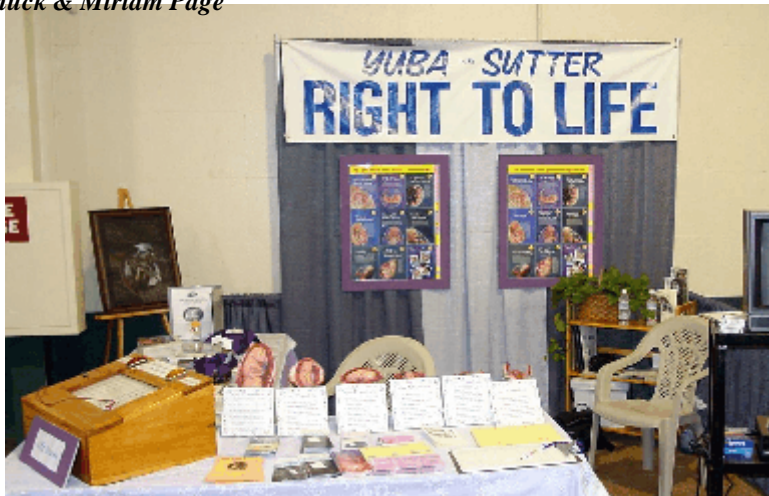
## *Yuba-Sutter Fair Recap*

The annual fair is our best opportunity each year for personal interaction and discussion with local residents. This year 1874 people (1260 adults and 614 children) made contact with our booth workers, and we distributed hundreds of pieces of literature. One hundred eighty three people signed our petition to the California legislature to stop funding abortions through MediCal. The biggest attraction this year was the addition of a “Test your knowledge about abortion” game box which challenged players to answer eight questions about abortion (see article on next page).

## *Crossroads*

Crossroads is a group of pro-life college students from around the country. Each year they start in San Francisco in early summer and walk across country to Washington, DC, witnessing the pro-life message along the way. They are sponsored by the American Life League. Brian O'Neel, Press Secretary, Office of California State Assemblyman Tim Leslie, sent the following message to a friend about Crossroads' visit to Sacramento:

“Just wanted to let you guys know about a little something that happened here in California. Crossroads was in Sacramento and I was arranging to have them introduced on the floor of the CA Assembly as we have in the past. I got prior approval from the Speaker's office and in the letter I even let them know that this was a pro-life group. We got approval and when Crossroads got here I picked up the guest passes and brought them into the Assembly chambers. The 15 walkers were wearing the big PRO-LIFE shirts as they always do. Well, shortly before my boss was to introduce them, he came back to let me know that the democrats (who are in the majority here in liberal California and have the ability to call all the shots) were NOT pleased with the walkers' shirts. In short, either we were to take them up to the gallery or they were going to be kicked out. Nice, eh? Now, get this, currently on display in the rotunda of the Capitol, arranged by the Speaker of the Assembly, is a whole exhibit dedicated to Gay, Lesbian, Bisexual and Transgendered Awareness month, highlighting our 4 gay members of the Assembly. Additionally, this is the same legislative body that had the prestigious distinction of honoring the first transgendered 'person' as 'Woman of the Year.' Oh, but we can't have proliferators on the floor of the assembly! And they call US the intolerant ones.”
