
September 7, 2012 (LifeSiteNews.com) According to [Apple's own internal investigation](#) performed this year, 24 of their facilities in China routinely conduct pregnancy tests to ensure workers are not "illegally" pregnant. It also found 56 facilities did not have policies or procedures in place prohibiting coercive family planning measures. Escaped Chinese dissident [Chen Guangcheng](#) is leading international opponents of forced abortion in calling upon the world's largest company to end compliance with China's one-child policy. "There's a huge social responsibility for these international corporations like Apple," Chen said. Two spokesmen for the Chinese embassy in Washington have not responded to requests from the media for comment.

October 4, 2012 (LiveActionNews.org) A new pro-life documentary produced by River Song Productions will be released. ["The Voice of John"](#) will discuss the reality of babies born alive after abortions and provide evidence of atrocities that occur with far too much regularity. "John" is not a make-believe person or a fantasy. He is a real baby who survived an abortion in 1977 and was then left to die by medical professionals. Found lying on a cold metal table by a young nurse, he was held in her arms, baptized, and named. "I name you John and I will tell the world what I saw here today. I will be your voice!" The documentary features Mike Huckabee, Abby Johnson, members of Congress, medical experts, abortion survivors, women who have had abortions, and former abortionists like Carol Everett.

October 11, 2012 (LifeSiteNews.com) A new documentary promises to expose the three deadliest words in the world: "It's a Girl." The trailer is making waves on the web and is shining a spotlight on female "gendercide". The filmmakers interview the families victimized by government population control policies, those forced into cooperation with those policies, and still others entrenched in deadly cultural traditions. This expanse includes the Chinese families whose children are killed by their country's Birth Control agents, Indian families killing their girls in preference of sons, and still other Chinese families who have abandoned their own daughters to the elements. October 8, 2012—Sweden (LifeIssues.org) Two scientists have been awarded the [Nobel Prize for Medicine](#) for their groundbreaking work in adult stem cell research. They discovered that adult stem cells can one day re-grow tissue in damaged brains, hearts or other organs. It also eliminates the need to kill human embryos in order to harvest their stem cells. Dr. Shinya Yamanaka, of Kyoto University in Japan and Dr. John B. Gurdon, of the Gurdon Institute in Cambridge, England will share the \$1.2 million financial prize, for a 2006 experiment that transformed the field of regenerative medicine. The science is still in its early stages, but in the six years since Dr. Yamanaka published his findings of adult stem cells, the discoveries have already produced dramatic advances in medical research. Dr. Yamanaka's paper has also been cited more than 4,000 times in other scientists' work.

September 20, 2012 (LifeIssues.org) Jeff Smisek, the President of United Airlines, has chosen to align with abortion giant Planned Parenthood (PP). Smisek is co-chairing a swanky fundraising event for PP in Houston; tickets start at \$500 each. This fundraiser benefits the largest abortion mill in the Western hemisphere that happens to be located purposefully in the middle of Black and Hispanic neighborhoods. Bradley Mattes, executive director of Life Issues Institute, stated, "When a prominent individual is willing to take such a blatant pro-abortion stand, we must be prepared to stand just as firmly on the side of life. October 9, 2012—Dallas, Texas (LifeSiteNews.com) This summer, 12 year-old Zach McDaniel was shot in the head as a bystander when he was caught in the crossfire of a drug deal. He was rushed to emergency surgery and then placed on a ventilator and put into a drug-induced coma. He was then transferred to another hospital where the staff pressured the boy's parents to sign an organ donation form after claiming his prognosis was poor. Texas law allows hospitals and physicians to terminate a patient's care after 10 days and an ethics committee at the hospital convened, decided that any further care for Zach would be futile, and moved to terminate his care. Zach's parents pleaded for the hospital to give him time to recover. Because of procedural mistakes made by the hospital ethics committee, the ruling did not stand and three days later, Zach was breathing on his own. However that same day, the boy's doctor secretly withdrew Zach's food and water and also slipped a "Do Not Resuscitate" order into his chart without his parent's knowledge or consent. When Zach's mother discovered the DNR and that her son wasn't receiving food and water, she called [Texas Right to Life](#) for help where she was advised to confront the doctor and promised legal aid if the need arose. When the mother confronted the doctor, he reluctantly reinstated the food and water and removed the DNR order, but made it clear that he no longer wished to treat Zach and advised her to find another place to take her son. Zach was moved to the [Children's Medical Center in Dallas](#) where doctors are hopeful and said that Zach had a survivable injury. They slowly weaned him off the sedatives to bring him out of his drug-induced coma. Now, Zach is fully conscious, talking, and receiving physical therapy. Texas Right to Life's legislative director, John Seago said, "Zach's recovery is a victory for life and a testimony that we should fight for all innocent human life without making arbitrary quality of life judgments."
